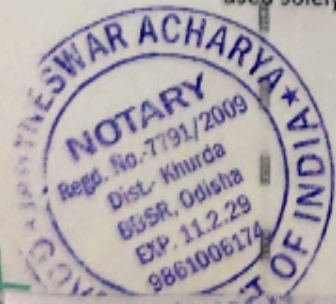

- 4.that, the school running as a community service and not as a business and that the commercialization does not take place in the school in any shape whatsoever.
- 5.that, no part of income from the institution shall be diverted to any individuals in the trust or to any committee members or any other person.
- 6.that, the saving, if any, after meeting the recurring and non-recurring expenditure and contribution to developmental, depreciation and contingency funds may be further utilized for promoting the school.
- 7.that the school is not paying any charges towards using names, logos, motto, or any other non-academic activities to any other institutions, organization or body organization.
8. that, the school will not open classes under CBSE pattern particularly classes- XI/XII and will not use logo and name in any manner without having/obtaining senior secondary affiliation.
9. that, the school is running now as CBSE affiliated Secondary Level school with Affiliation No-1530290/ School Code-15906. No sponsoring of students' available at this School.
- 10.that, the school is not part of any franchise arrangements as per clause-19.1(I)(II)& clause-7.2
- 11.that the Trust operates for public service rather than private profit, ensuring no income or assets are diverted to trustees, members or individuals. It is a Not-for-profit structure, where earning are used solely for the institution's development.
