Training sessions are conducted for the faculty and staff to recognize and report issues of abuse and neglect. Complaint boxes are placed strategically and checked regularly by the committee members to address complaints, if any. Through awareness campaigns and programs, the committee strives to ensure that all learners are treated with dignity and respect at all times. A series of awareness programs and special school assemblies are conducted throughout the year, and learner participation is encouraged. Age-appropriate videos are shown and self-defense sessions are also conducted as part of the awareness programs.
