AND WHEREAS, all the previous Trustees & new comers, Trustees unanimously elected **SMT. NIRUPAMA PATRA** to continue as "MANAGING TRUSTEE" until her death and allowed to avail all power given to MANAGING TRUSTEE in it resolution.

NOW THIS INDENTURE WITNESS as Follows:-

1. A meeting of the present MANAGING TRUSTEE and TRUSTEES held on 05th day of January 2021 and it has been unanimously decided to continue the trust in the name and the style of "**BNR EDUCATIONAL & CHARITABLE TRUST**" (hereinafter referred to as "THE TRUST") and the office of the TRUST was functioning/situated at Plot No-209/A, Saheed Nagar, Po/PS-Saheed Nagar, Bhubaneswar-751007, Dist-Khurda, Odisha, which will be shifted from time to time to such other place or places as the TRUSTEES may deem fit and proper at their discretion. The office of the TRUST will at present be function/situated at Plot No.MIG-II-203, Kanan Vihar, Patia, Bhubaneswar-751031, Dist-Khurda, Odisha.

In order to effectuate the said objects of creating and establishing a public Charitable Trust, the MANAGING TRUSTEE delivered to and made over to the TRUSTEES a sum of Rs.10,000/- (Rupees Ten Thousand) only with intent to part with all her right, title, interest and claim therein and vest the same in the TRUSTEES to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the TRUST (hereinafter referred to as the TRUST FUND) for charitable objects and purposes and uses hereinafter expressed with the powers and on the terms and conditions herein contained of and concerning the same. These Rules shall be interpreted in pursuance with the provision laid down here under & in case of disputes, shall be interpreted as per the provisions of the Indian Trust Act of 1882.

5. **OBJECTIVES:-**

The objects of the Trust shall be:-

The Trust without prejudice to the provisions laid down in the Indian Trusts Act 1882 shall have the following objectives:

i. To establish, promote, set up, run, maintain, assist, finance support and /or aid to or help in the setting up and/or maintaining and/or running school, college, other institution or other establishment for help, relief to needy & poor students and concept development of people.
